Subject: **Issuing of Sports Gradation Certificates-Reservation of seats for sportsmen/women in Technical/Medical and Preferential treatment in Services of the State Govt.**

Sir,

I am directed to refer to Punjab Government instructions contained in circular letter No. 47/26/83-5Edu(5)/1490 dated the 7.6.91/12<sup>th</sup> June, 1991 on the subject cited above and to say that after careful consideration, Government have revised as follows, the criteria for the grant of Sports gradation certificates for entitlement to the concessions based thereon:-

2. The certificates shall be in the following decedding order of merit:-

**Grade-A:**

Sportsmen/women of International standing i.e. those who have represented India in the following International tournaments/Meets/Competitions/Championships etc.:-

- i) Olympic Games
- ii) Commonwealth Games
- iii) Asian Games
- iv) Test Matches/One day matches in cricket.
- v) Davis-Cup in Tennis.
- vi) World Cup tournaments in respective Games.

**Grade-B:**

Sportsmen/women who have participated in the following tournaments/Meets/competitions/championships etc.

- i) Asian Federation Cup Tournaments.
- ii) International tournaments other than those mentioned against grade-A.
- iii) All India combined Universities team which participated in the Senior National.
- iv) K.V.S. team participation in the National School Games.
- v) National Championships/Inter-State Championships organized by the recognized National Federations.
- vi) International meets/championships for juniors.
- vii) National games organized by I.O.A.
- viii) All India combined Universities team participating in World Universities championships.
- ix) National Championships for women/National Sports festival for women organized by SAI from 1990-91 onward.
- x) National School Games.

**Grade-C:**

Sportsmen/women who have participated in the following tournaments/championships/meets etc.

- i) All India Inter-versity tournaments.
- ii) Inter-District State Championships organized by the recognized State Sports Associations.
- iii) Punjab State Games organized by POA.
- iv) Punjab State Championship for women organized by the Punjab Sports Department.
- v) State School Games organized by the Punjab Education Department.

**Grade-D:**

Sportsmen/women who have participated in the following tournaments/championships/meets etc.

- i) District level competitions organized by District Sports Associations.
- ii) Inter-college university tournaments.
- iii) Inter-Schools District Tournaments.

2. Performance in the following Sports disciplines only will be considered for the purpose of sports gradation:-

Note: For certification, Sports Department Punjab, only entertains the claims of residents in the State and the Union Territory of Chandigarh (The later in only entertained for counters signatures of certificates issued by Department of Sports, Union Territory, Chandigarh). This leaves out the sportsmen-residents of other states even of Punjab who do not represent Punjab or any institution in Punjab in any competition.

3. In the matter of rating, interse, the preference in the same grade will be given in the following descending order:-

- a) Record Holders in any event.
- b) Winners.
- c) Runners up.
- d) Third position holders.
- e) Number of times participated.
- f) Number of disciplines participated.

Note:- 1 Regarding Senior and Junior Tournaments/Championships, Senior shall have prescedence over Junior, Moreover Junior and schools championships will be considered at par.

- 2 No Sports gradation certificate shall be issued to the players who participated in Mini, Sub-Junior and in the tournaments which are organized for the players under 15 years age.

4. Participation in a lower grade shall be pre-requisite for acceptability in the higher grade. For instance, no achievements in Grade A would be recognized if it is not shown to have been achieved through participation in grade 'B', 'C' and 'D'. Similarly for recognition of an achievement in Grade 'B' participation in Grade 'C' and 'D' will be necessary.
5. The disciplines like Athletics etc. position achieved will be considered only if it has been achieved through a competition with seven or more competitors from atleast seven units/states.
6. Only Those certificates issued by the concerned sports bodies as are properly signed in ink by atleast two office bearers thereof should be entertained applications shall only be received through an affidavit affirming the correctness of the claim(s) duly attested by the Magistrate Ist Class on a non-judicial paper.
7. The applicants shall be interviewed and may also be given field test(s) in the discipline(s) concerned to ascertain the correctness of the testimonials/certificates(s) which they produce in support of their claim(s) to make the grading of the candidates(s) not merely on the basis of the certificate(s) but by examination from other appropriate aggles.
8. Director Sports, Punjab who will issue the certificates will also have the authority to cancel any certificate at any time, if it is found to have been issued on false/incorrect information or record.

Sir,

In partial modification in the instruction issued vide Circular letter No. 47/26/83-5Edu(5)/1999 dated 4<sup>th</sup> August, 1992 on the subject noted above, I am directed to inform that Note-I of Para 3 may be read as under:-

“Regarding Senior and Junior Tournaments/Championships Senior shall have precedence over Junior in the same performance i.e. for example Gold Medalist in Senior category shall have precedence over Gold Medalist in Junior category and Gold Medalist in Junior category over Silver Medalist in Senior category and so on. Moreover Junior and Schools Championships will be considered at par.”
