- (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- 2. In the Punjab State Sports (Group 'C') Service Rules, 2023, (hereinafter referred to as the said rules), in Appendix 'A', under column 3 and 5, in serial number 1, for the figures "273", the figures "358" shall be substituted. The breakup posts amongst various games is Annexure 'A'.

4.Method of Appointment:

- (i) Only those candidates who qualify the physical eligibility test shall be eligible for written test
- (ii) Criteria for Physical Eligibility Test It is a qualifying test wherein the candidates must complete any three of the five test components specified in the table below:

Male:

- (a) 30 meter Flying Start (for speed) (5 sec)
- (b) Standing broad jump (for explosive strength) (1.40 meter)
- (c) Shuttle run 6X10 meter (for agility) (17.50 sec)
- (d) Bend & reach (for flexibility) (2 cm)
- (e) 1600 meter running (8 minutes)

Female:

- (a) 30 metre Flying Start (for speed) (5.80 sec)
- (b) Standing broad jump (for explosive strength) (1.20 metre)
- (c) Shuttle run 6x10 metre (for agility) (18.50 sec)
- (d) Bend & reach (for flexibility) (2 cm)
- (e) 1600 metre running (9 minutes 30 second)
- (iii) Combined Merit- Weightage for recruiting candidates shall be as follows component:
- A) Written Test: Weightage -70%
- B) Sports Weightage -30% Sports Achievement based on gradation issued by the, Department of Sports.

Note I: The above sports achievement weightage shall have no effect on the recruitment of candidates applying under sports quota. For these candidates, the Punjab Sportsmen Recruitment Rules 1988, as amended from time to time, shall remain applicable.

Note II: In case of multiple gradation certificates, a candidate shall be given weightage for the higher gradation certificate only.
